Alliance Person Centered Thinking Committee Update

PCT Committee formed in 2014 with the charge of improving services through person-centered practices

The first task was to seek out funding for training to make this goal reality

The first *step* was to approach the Daniels Fund with a carefully developed grant request idea

- In 2015 Alliance was awarded a grant in excess of \$83,000 from the Daniels Fund
 - To provide statewide Person Centered Thinking trainings to:
 - people with IDD
 - their families
 - professionals working in the IDD system
 - To provide training to and certification of additional trainers in PC practices, especially in rural areas
 - To track outcomes
 - how many people trained
 - how many newly certified trainers
 - increased job satisfaction
 - increased satisfaction of the quality of services provided to people with IDD and their families as a result of providers completing the trainings

- In 2015 the Colorado General Assembly appropriated \$500,000 to the Department of Health Care Policy & Financing (HCPF)
 - To conduct statewide Person Centered Thinking trainings
 - HCPF selected Support Development Associates (SDA) as its training vendor
 - SDA collaborated with the Council on Quality and Leadership (CQL)
 - SDA contracted with Alliance to coordinate the trainings

SUCCESS!!

- 96 trainings were conducted in every area of the state between February and June 2016
- ■2,527 people attended the trainings

Next Phase of Daniels Fund Grant Train and Certify PCT Trainers

- Individuals and agencies were offered an opportunity to apply for funding for committed individuals to become credentialled PCT trainers
- Awarded approximately half of the grant funds to individuals or agencies that applied for funding
- 9 grant awards were made
- All 9 awardees selected training based on the The Learning Community for Person Centered Practices (TLCPCP) curriculum offered by SDA.
- 8 trainers have been certified and 2 more are in the process
- Alliance is in the process of collecting information from awardees
 - how many people they have trained to date
 - their plans for future trainings inside and outside their agencies

Next Phase of Daniels Fund Grant – Training offered to Individuals and Families

- Alliance worked with SDA to hold
 - ■3 Families Planning Together classes
 - 2 People Planning Together classes
 - which are specifically designed to engage selfadvocates and families in the person-centered process
 - while attendance at these trainings was low, the feedback from those who attended was very positive

Critical observation

We learned that more targeted strategies are needed to engage self-advocates and families in PCT concepts

What we have learned through surveying participants and people supported:

- Approximately 50% of respondents were Direct Service Providers/Direct Support Professionals
- Approximately 83% of respondents reported that they had not previously attended a person-centered training
- Respondents reported significant increases in a number of skill areas after the training, including being able to describe person-centered training to someone who has no knowledge about it, understanding how to discover what is important to and what is important for someone, and understanding the difference between supporting and fixing a person
- Respondents reported only a 7% increase in job satisfaction or feeling supported in their roles. However, on the post-training evaluation, over 85% of respondents felt that the skills and tools learned in the training would help to increase their feelings of job satisfaction. We believe that this shows that a one-time training doesn't do much to boost job satisfaction among DSPs, but that implementing the tools and practices agency-wide could have a significant impact on DSP job satisfaction, and possibly help to reduce our statewide 39% DSP turnover rates
- After the training, individuals served reported significant increases in their satisfaction level with their services and their ability to express preferences to their providers

The Daniels Fund grant comes to an end on June 30, 2018 and the final report is due in July. "This is the end, my beautiful friend" Nope...

Our work is far from done, actually it has just begun

Committee next steps

- Define Person Centered Thinking and Person Centered Planning
- Survey Service Providers and CCBs to assess:
 - Participation in PCT training
 - How are you preparing for Person Centered Plans related to the federal HCBS settings final rule?
 - Barriers to organization-wide implementation of personcentered plans
 - And more....
